- All speed limits must be observed: 10 mph in the parking lot and 25 mph in a school zone. Reckless driving will result in the loss of parking privileges.
- If your parking privileges have been removed over at Cave Spring High School, you may NOT park here.
- Please do not park in handicap, guest parking, or next to building (between sidewalks that enter the main building.)
- Please do not park near the upper building or playground areas, only in the front, main parking lot.

Release of Liability

I hereby release Penn Forest Wesleyan Church (aka Penn Forest Worship Center) of any responsibility or liability for loss and/or damages to my vehicle, including but not limited to partial or total theft, collision, fire, acts of god, weather, construction, etc. during the course of my car parking in the church parking lot. I have read the Parking Policy and understand all the regulations for proper parking, driving and conduct.
